1. Call to Order

a. The Cottonwood Water District Board of Director's meeting was called to order at 4:01pm by Nick Shidlovsky, Chairman.

3. Consent Agenda Items

- a. Approve minutes of the Regular Board Meeting September 11th, 2024.
 - 1. A motion to approve minutes of the Regular Board Meeting September 11th, 2024 was made by Spurgeon and seconded by Presley. 3 yes votes, motion passed.

4. Regular Agenda Items

- a. General Manager Update
 - Emergency Repairs Update
 - John showed a slideshow of the various projects completed by the crew the last few weeks. Repairs off Gas Point & Rhonda, Savage, school track area and down by the shop off Rhonda.
 - Grant Update
 - A notice was received that the State is currently out of funding. The engineering costs has funding available but no current funding for construction. The funding reward for ACWA JPIA closed September 30th. We did receive the small funding they had available ACWA JPIA risk control grant funding award of \$2,164.70 back in April 2024. John made a suggestion after speaking with the rep at JPIA that our District could try again for the new year of grant funding award of the larger amount but we would need to return the small funding award back to qualify.
 - Audit Complete
 - Audit went great. Candice did all the preparations and worked with Larry Bain and remotely with his partner to get it done in two days. No serious issues were discovered, the managerial reports will come next meeting.
 - John brought up discussion of some new equipment requests for the District such as new excavator, new service truck, new truck for Lead Operator, fuel storage and walk behind saw. The mini excavator can likely sell for about \$32,000.00 to get what the District paid for it. The service truck needs to be a 1-ton, single cab and with hopes to remove the bed off the current service truck to add on to the new one. A new Kubota KX40 or KX35 is roughly \$45,000.00. The best truck for the operator would be Dodge Ram 1-ton so it can tow and diesel so all things run off the same. A motion was made to approve John to spend \$50,000.00 on a new truck was made by Shidlovsky and seconded by Presley. 3 yes votes, motion passed.

 - 1. Closed session began at 4:51pm. Closed session ended at 4:58pm. No action was made. Board members requested to have vacation policy included in the next board packet.
